The construction of composite Op-Amp has the same construction as the single Op-Amp, namely, two input terminal and one output terminal. Problems that often occur in the system is the reduced power cellular accept that emanated in the base station to mobile station. Then how to set the power scattered between the BTS and MS so that power received by consumers still going maximum if the number of the requests from the channel capacity exceeds the maximum coverage of the cell traffic of the cell will experience a contraction in that traffic does not exceed its maximum capacity, but when the number of channel requests return to normal conditions as the original cell coverage expands again, so that customers are able to the maximum cell radius can be served. Analysis of the results in the PT. Telkom initial condition where the scattered power BTS A sector of 36dB, the power received by the BTS power is still above the minimum required on 0,5 – 4,0 Km radius but when reached 4,5-5,0 Km radius of power PRX is 112,09 dB then the power received through the restrictions MS has received the minimum power, so that communication between the base station with a radius on the MS will be cut off.
